MINUTES OF THE MEETING OF WINNERSH PARISH COUNCIL HELD REMOTELY ON TUESDAY 12 JANUARY 2021

- 2 **DECLARATIONS OF INTEREST:** None
- 3 MINUTES OF THE LAST MEETING AND MATTERS ARISING
- 3.1 The minutes of the Parish Council meeting held on the 8 December 2020 were **APPROVED**, and the Parish Council **RESOLVED** that the Chairman should sign them as a true record.
- 3.2 Minute Item 4.3: The Q2 Accounts had been circulated and the Parish Council **RESOLVED** to approve them.
- 3.3 Minute Item 6.4: The Clerk confirmed that he had made the offer to provide the Winnersh Community Centre as a COVID-19 vaccination centre.
- 3.4 Minute Item 18.1: The Clerk confirmed that he had registered the Parish Council's support of the Local Electricity Bill.
- 3.5 Minute Item 19.1: The Clerk confirmed that the Parish Council's response to the consultation on the Code of Conduct for Elected Councillors had been submitted to Wokingham Borough Council.
- 4 **PUBLIC SESSION:** There were no members of the public or press in attendance.
- 5 COVID-19 PANDEMIC
- 5.1 The Clerk gave an update on the latest lockdown that was effective from the 5 January 2021, explaining that WPC facilities were closed, with the exception of play areas,

allotments and the Bearwood Recreation Ground that was available for exercise but not for football or exercise classes.

6 WOKINGHAM BOROUGH COUNCIL MATTERS

6.1 Borough Cllrs Bray, Fishwick and Shepherd-DuBey gave an update on WBC matters (Appendix 1), and these were noted.

7.1 There were no questions on Parish matters.

8 REPORTS FROM REPRESENTATIVES ON OUTSIDE BODIES

8.1 There had been no meetings of outside bodies for Parish Councillors to attend.

9 PLANNING COMMITTEE

9.1 The minutes of the Planning Committee meetings held on the 17 November 2020 and 7 December 2020 were noted, having been approved by the Planning Committee on the 11 January 2021.

10 CLIMATE CHANGE EMERGENCY

10.1 The Chairman advised that an update would not be available until after the next meeting of the Climate Change Emergency Working Group, that would take place on Wednesday 13 January 2021.

11 WINNERSH/WINNERSH TRIANGLE RAILWAY STATIONS ADOPTION

11.1 The Chairman advised that there was a delay with the shelters artwork project as schools had closed in line with lockdown legislation, and the proposal to invite Forest School to participate would be put on hold. In the meantime, and as an alternative, CLASP (Wokingham), a local charitable organisation supporting adults with learning disabilities, was being invited to design artwork for the Winnersh Triangle Station.

12 HISTORY PROJECT

12.1 Cllr Obileye advised that the process of validating documents and artefacts was progressing well and that the next meeting of the History Project Working Group was scheduled for Thursday 21 January 2021.

13 SCHEDULE OF PAYMENTS

The schedule of payments, due since the last meeting, was circulated in advance of the meeting (Appendix 2), and upon the **PROPOSAL** of Cllr Harper, **SECONDED** by Cllr Krauze, the Parish Council **RESOLVED** to make payments totalling £14,625.40. The schedule included a duplicate payment to Astro Signs and this would be corrected and the revised schedule would be shown in the minutes of the meeting.

- 13.2 Cllr Harper asked about allotment deposits as those shown on the schedule of payments did not match the list of allotment holders that were due to have their deposits returned. The Clerk advised that not all allotment holders had provided their bank details and upon receipt of this they would be included on the schedule of payments for a future meeting.
- 13.3 The bank balance at the 31 December 2020 was confirmed as £191,369.48.

14 WINNERSH FETE 2021

- 14.1 A discussion took place about the possibility of the Fete taking place on Saturday 4 September 2021, given the concerns about how long the Coronavirus pandemic would continue.

The following are a summary from meetings held at the Borough Council that I have attended since the Winnersh Parish Full Council meeting on 2nd December 2020.

22nd December – Extraordinary Community and Corporate Overview and Scrutiny Committee

Winnersh specific

Winnersh Relief Road Phase 2 – opening in early 2021

Work is progressing to extend Longdon Road to a new roundabout on Reading Road by the M4 overbridge (Winnersh side). The councils plan to open the new roundabout in January 2021 were delayed by a month and now plan to open the new road and the roundabout during early February.

Temporary traffic lights will remain in operation at Woodward Close junction until late March/early April 2021. However, a right-turn ban on traffic entering Woodward Close from the A329 Reading Road will be brought into operation when the new roundabout opens.

During late March/early April 2021, the roundabout near the BP garage will open and traffic exiting Woodward Close will only be able to turn left from that time. The existing temporary traffic signals at the Reading Road / Woodward Close junction will be removed and a new toucan crossing will be installed between Woodward Close and the new roundabout on the Sainsbury's side.

Street and footway sweeping

I have reported numerous streets (carriageways and footways) that have not swept correctly or not at to Wokingham Borough Council. Wokingham Borough Council's web site has a page

related to Street Cleansing where a resident can look up a street and information is made available as to the frequency of sweeping, when it was last swept and the next scheduled visit. However, I have found at least one street that was missing from the schedule Robinhood Way. This has now been swept. Street cleaning - Wokingham Borough Council

Gully Cleansing

I have reported numerous blocked gullies in the area since the last update. The B3030 Robinhood Lane caused concern as the majority of gullies were blocked. These defects also extended into Arbor Lane. Wokingham BC think that the last cleanse was missed and have ordered these to be cleaned this month.

B3030 King Street Lane Zebra crossing

The Parish Council raised safety concerns with the Borough Council about this crossing, initially in October 2017 and further correspondence on the matter continued for a time after that.

Now that the King Street Lane junction with Hatch Farm Way has been signalised with pedestrian light-controlled crossings, a Facebook poll was carried out by your Borough ward councillors earlier last year where 82% of respondents supported the removal of the zebra crossing.

Following that survey, and the strong indication given by respondents, your Borough ward councillors have set up a Petition asking residents to sign in support of the zebra crossings removal and make King Street Lane safer.
