Minutes of the **PLANNING & TRANSPORT COMMITTEE** meeting held at Winnersh Community Centre on **Tuesday 14 February 2023** at **19.30**.

3. **Public Session**: There were no members of the public in attendance.

4. Minutes of the previous meeting

- 4.1 The minutes of the last meeting held on the 10 January 2023 were noted and approved. There were no matters arising.
- 5. The committee considered the following planning applications: -
- 5.1 **Application Number**: 223840

Site Address: Wildewood, Simons Lane, Wokingham, RG41 3HH **Proposal:** Householder application for the proposed conversion of existing garage to create habitable accommodation plus single storey front and side extension. Single storey side extension. Erection of 5.2m pergola to the rear garden. Installation of 2no. air conditioning condensing units. Erection of 1m fencing following removal of existing boundary wall.

The committee noted the application had already been approved.

5.2 **Application Number**: 230050

Site Address: 30 Arbor Lane, Winnersh, Wokingham, RG41 5JD

Proposal: Householder application for the proposed conversion of existing garage to

create habitable accommodation, to include rooflights.

The committee made no observations on the application.

5.3 **Application Number**: 230076

Site Address: 36 Danywern Drive, Winnersh, Wokingham, RG41 5NR

Proposal: Householder application for the proposed erection of a first-floor rear

extension, and changes to fenestration.

The committee made no observations on the application.

5.4 **Application Number**: 221312

Site Address: Land at Duffet Drive, Winnersh, RG41 5TA

Proposal: Application for submission of details to comply with the following condition of planning consent O/2006/8687 (060468) dated 19/11/2014. Condition 6 relates to hard and soft landscaping details and the application is for partial discharge of this condition relating to the NEAP only.

The committee made no observations on the application.

5.5 **Application Number**: 230099

Site Address: Land to the South of Gazelle Close, Winnersh, RG41 5HH

Proposal: Full application for the proposed erection of a foodstore with associated access, parking for 124No spaces and servicing areas, landscaping, and other associated works to include Solar panels to the roof.

The Committee have raised the following concerns:

1. Flood Risk

Is the +25% allowance for climate change sufficient?

2. Travel

Are the 8 cycle spaces for the public covered by CCTV? The Committee noted the positioning of the spaces are hidden and therefore concerns were raised about potential crime.

The Committee also noted there were discrepancies within the report regarding the number of spaces for both cyclists and motorists.

3. Traffic

The Committee are concerned about the management of future traffic and turning right from the junction. This is currently a left turn only exit but is often abused by drivers turning right. An increase in traffic will create more vehicles turning right illegally increasing the road safety risk. As a result, the junction will require better measures to stop the right turning traffic. The Committee are concerned that if traffic signals are installed this will place pressure on the Winnersh crossroads.

Proposal: Householder application for the proposed erection of a two-storey rear extension with 1 no. Juliet balcony and a single storey side/rear extension to the existing detached garage linking this to the main dwelling.

The committee made no observations on the application.

Site Address: 1 Upper Terrace, Bearwood Road, Sindlesham, Wokingham, RG41 5BT **Proposal:** Application for Listed Building Consent for the proposed demolition of the rear utility room extension and alterations the original wall line with a new kitchen window; to create a French drain and lower the patio; replace existing patio doors in a wider opening; to replace the existing dining room door and side window with a window; reverse the open-plan hall formation to enclose the new living room with new structure and lightweight walls; and replace the modern staircase to create the space for the new Living Room walls; to adjust the existing internal Kitchen door opening; relocate two original doors to one new door to the Bathroom; replace two modern fireplaces.

The committee made no observations on the application.

Proposal: Householder application for the proposed erection of a first-floor side/rear

extension.

Proposal: Householder application for the proposed erection of a first-floor side extension, plus alterations to existing single storey rear roof, addition of PV panels and changes to fenestration.

The committee noted there was no site plan attached and therefore unable to review the application.

Site Address: Land located to the east of Watmore Lane/Maidensfield, Winnersh **Proposal:** Outline application with all matters reserved except access for the proposed erection of up to 234 dwellings.

Site Address: 22 Sadlers Lane, Winnersh, RG41 5AG

Proposal: Application for the prior approval of the erection of a single storey rear extension, which would extend beyond the rear wall of the original house by 8.00m, for which the maximum height would be 4.00m and the height of the eaves 3.00m

The committee noted that insufficient information is attached to this application, so unable to make an observation. The application should be rejected in its current form and additional documents such as existing and proposed elevations and floor plans should be submitted.
