#### Minutes of the **RECREATION AND AMENITIES COMMITTEE** meeting held on **Tuesday 4<sup>th</sup> July 2023 at 7.30pm** at the Winnersh Community Centre

#### 1. APOLOGIES FOR ABSENCE

#### 2. DECLARATIONS OF INTEREST

#### 3. MINUTES OF THE PREVIOUS MEETING

The minutes of the meeting held on 6<sup>th</sup> June 2023 had been approved and signed at the Council meeting on 20<sup>th</sup> June 2023.

The Clerk's report with updates on matters arising from previous meetings was attached at Appendix 1. **Noted.** 

Cllr Southgate asked that updates from the previous month be highlighted to make them easily identifiable.

Cllr Doyle reported that she had received one quote for replacing the curtains which was over the current budget. She advised that she was in the process of obtaining additional quotes but noted there may be a requirement to increase the current budget.

Cllr Green asked whether the existing curtains could be repaired but it was noted that they were perishing in places and therefore full replacement would be required.

## 4. BERKSHIRE YOUTH

#### 5. WINNERSH ALLOTMENTS

The Committee had carried out a site visit of the allotments immediately prior to the meeting.

- i. Lease amendments a final draft Deed of Amendment and map is awaited. **Noted.**
- ii. The construction work on the Oak Tree School and access road is nearing completion. The Clerk, CELO and Cllr Harper are meeting with Reds10 and WBC on 11th July to discuss any remedial works required to the allotment site prior to Reds10 leaving site. **Noted.**

#### 6. WINNERSH RANGERS FC AGREEMENT

A draft agreement for WRFC storage, matches and training at Bearwood Recreation Ground for 2023/24 was attached at Appendix 2.

The Clerk had proposed an increase of 7% to all charges in line with the other facility charge increases agreed in February 2023.

It was **RESOLVED** that a 7% increase be applied as per the Clerk's proposal.

# 7. CAPITAL PROJECTS AND BUDGET REVIEW 23/24

An update on 2023/24 capital projects was attached at Appendix 3. Noted.

i. Toilet Refurbishment – the Clerk had only managed to obtain one quote for complete replacement of the toilets which was substantially over budget.

The Clerk had suggested that a partial refurbishment may enable the project to go ahead within budget and achieve a similar outcome. This would include replacement of only flooring, tiles, taps, hand driers, toilet roll and soap dispensers plus redecoration throughout. An additional baby changing unit could be installed in the men's toilets. The existing sanitaryware, mirrors and partitions were in reasonable condition and could remain in situ.

It was **RESOLVED** that the project detail be amended to refurbishment rather than replacement and the Clerk was asked to obtain quotes.

# **ACTION: CLERK**

ii. Path Renewal – the Clerk advised that she was still working on obtaining revised quotes.

Cllr Green suggested that consideration be given to replacing the broken slabs only at this stage as the Allnatt Pavilion survey had identified the path to be in reasonable condition. A full replacement could be investigated once any major works had been completed on the Allnatt Pavilion which could include route amendment. The Clerk was asked to obtain quotes for both options.

## **ACTION: CLERK**

iii. Pavilion House – it was noted that once the improvement works had been completed, annual inspections should be reinstated.

# AGREEMENT BETWEEN Winnersh Parish Council and Winnersh Rangers Football Club For the 2023/2024 Football Season

This agreement covers the use of the Winnersh Parish Council (WPC) football pitches and storage at the Winnersh Community Centre, New Road, WOKINGHAM, RG41 5DU by Winnersh Rangers Football Club (WRFC) during the 2023/2024 football season.

## **Use of the Football Pitches**

WRFC games will be accommodated subject to pitch availability and fitness.

WRFC will supply the contact telephone numbers of two officials who can be informed of pitch playability. The Grounds Contractors will perform an inspection on each Friday during the season. If, for any reason, they deem any pitch unplayable on the Saturday and/or Sunday, notification will be made to one of the two nominated WRFC officials on the Friday. If the pitch is passed fit on the Friday but the pitch condition deteriorates subsequently before a match is due to be played, it is the referees' and WRFC responsibility to call off matches.

If pitches are used against instruction from WPC, WPC reserves the right to terminate this agreement.

## Dates for 2023-24:

The WRFC season will commence 2<sup>nd</sup> September 2023 and run until 28<sup>th</sup> April 2024. Evening training will take place on Tuesdays, Thursdays and Fridays for 6 weeks commencing August 2023 and during April and May 2024.

# Car Parking

Cars are to be parked in the car park at the owner's risk, in such a way as to cause minimal disruption to other hirers. If the car park is full, WRFC will ensure that all WRFC visitors, players and officials park in New Road, Mole Road or Bearwood Road, taking care not to block residents' driveways. Cars parked in the surrounding area must not impede or inconvenience local residents. If complaints are received from residents then future matches may be in jeopardy.
